## FROM THE PRESIDENT'S DESK



## **Dear Colleagues**

It is good to be back at my desk after a fairly busy four weeks. In late July, as President of ANZAM, I attended the International Federation of Scholarly Associations of Management (IFSAM) Council meeting in Shanghai, held over the two days prior to the IFSAM Conference, which was hosted by Fudan University this year. The IFSAM Conference is held very two years, drawing together management scholars from across the world. Representatives from most of the European and Asian Academies, as well as from Canada, were present at the IFSAM Council meeting, enabling useful discussion between representatives about the issues they face in their own contexts. The next IFSAM Conference will be held in 2010 in France.

In early August, I attended this year's Academy of Management Conference in Anaheim, where there were well over 200 representatives from Australia and New Zealand participating in the various divisions. It was a pleasure to see many of you attending the ANZAM Dessert Reception on the evening of the 10 August. Our presence at this international conference was designed to showcase not just the activities of ANZAM, including our revamped *Journal of Management and Organization*, but also the profile of our Institutional Members. Thank you to all the Institutional Members who forwarded images to include in the slide presentation. eContent Management, the publishers for our journal, were also exhibiting at the conference, with the aim of further building up the international profile of JMO.

I would like to thank Professor Julian Teicher, and the Membership and Profile sub-committee of the ANZAM Executive, for taking the lead in developing the ANZAM submission for the Bradley Review into Higher Education, which was submitted on 31 July 2008. As ANZAM's aim is to advance scholarship and practice in management education and research, our submission attended to a subset of the questions where we felt we were able to present a generally representative view of members with respect to key issues relating to management education in the higher education sector.

Once again the mid-year Doctoral Workshop held in Brisbane in early June received very positive feedback from the participants. Many thanks to Griffith University for hosting the workshop at their South Bank campus, and to the ANZAM Research Fellows who shared their time, knowledge and experience with those attending. Kathleen Mendon and Alberto Melgoza, our doctoral student representatives on the Executive Committee, worked hard to ensure its success and have taken on board feedback from those attending to help plan for the December doctoral workshop in Auckland just prior to the ANZAM Conference.

As you know, the theme of this year's conference is Managing in the Pacific Century and is to be held at the University of Auckland Business School, under the leadership of Professor Marie Wilson with support from Promaco, 2-5 December 2008. The key note speakers are Professor Anne Tsui (Arizona State University and Distinguished Visiting Professor at Peking University) and Professor Kulwant Singh (National University of Singapore Business School). The conference has received over 470 submissions of papers and workshops with a strong mix across the different streams. We are looking forward to a very full conference programme. # The ANZ Contingent at 2008 Academy Meetings in Anaheim

The 2008 annual meeting of the Academy of Management was held in Anaheim, California (8-13 August). Included in the program were 263 participants from Australia and New Zealand. The contingent included representatives from 38 ANZ educational institutions, and 6 consulting organisations. The University of Melbourne, with 25 participants (including 4 from MBS), headed the list. Other Australian institutions represented were Monash (22), UNSW (20), UTS (17), QUT (13), UQ (11), Macquarie (10), UWA (10), Deakin (9), Griffith (7), RMIT (7), Adelaide (7), UniSA (7), Sydney (6), and Swinburne (5). Also included were representatives from ANU, Ballarat, Bond, Canberra, Charles Sturt, Curtin, La Trobe, Newcastle, Southern Cross, Sunshine Coast, UNE, UWS, VUT, and Wollongong. New Zealand's participating institutions were led by Massey (14); followed by Vic (8), Auckland (7), AUT (6), and Waikato (6). Others from NZ were Canterbury, Lincoln, Open Poly, and Otago.

At the conference, ANZAM hosted a successful "Dessert Reception" on 10 August.

## University of Southern Queensland News Release Fowler Shares Insights into Managing International Partnerships

Tim Fowler, Pro-Vice Chancellor International of University of Southern Queensland recently addressed the Australian and New Zealand Academy of Management (ANZAM) during a workshop on the theme of "Managing International and Corporate Partnerships". "About 30 Institutional members of Australian and New Zealand members found that Tim's account of the major success factors in managing international partnerships was an eye-opener", said Prof Ronel Erwee, USQ ANZAM representative.

Tim emphasised that when managing international business partnerships within universities the key determinant of success is the level of sophistication with which the organisation approaches its own internal business management. He challenged the Australian and New Zealand universities that they were generally ill-prepared, did not experience internal buy-in or understanding from university staff or were overly optimistic about their own abilities to deliver.

He was concerned that many universities have done little work into realistically modelling likely outcomes – financial or otherwise. Members of the audience agreed that many universities are "lured by the revenue, not the margin".

Tim recommended that "Strategy is important but is a waste of time without the building blocks of the right people on the bus, the right structures and the incentives to participate – financial model and academic model in this case"

ANZAM members agreed with Tim that a university has to have clarity of engagement models, both internally and externally with the offshore partner. These models are the partnership engagement model, the academic model/financial model as well as the business relationship management model

Tim cautioned that balance is crucial in corporate governance. "Without it you have disasters; with overly zealous governance you have no business" he said.

He also lamented that the need for internal marketing and team development were greatly undervalued as part of the process yet possibly the most important in the implementation phase of any new offshore partnership.

Tim highlighted the progress that USQ made over the years in re-evaluating USQ partnerships, internal restructuring, governance and engagement. "We have made significant improvements in our partnerships and have reduced their number from over 60 to 25 but the job will never be finished", he said.

"ANZAM members confirmed that the issues he raised are faced by all of the business schools in the audience and they were riveted for the entire length of his presentation", said Prof Ronel Erwee. They agreed with Tim's comment that "International education business partnerships are great business if done well and a minefield if not".
