# FROM THE PRESIDENT'S DESK



# **Dear Colleagues**

This year's ANZAM Dessert Reception at the Academy of Management (AOM) Conference in Boston was another great success. As one of the great international gatherings of Management academics, the ANZAM Dessert Reception at AOM provides an excellent networking opportunity for our ANZAM members and promotional opportunity for ANZAM member institutions, ANZAM's official journal, and the upcoming ANZAM Conference. The 2012 AOM Conference program listed some 373 participants from Australia and New Zealand, representing 39 of our ANZ tertiary institutions.

As ANZAM President, I attended the "Forum for Leaders of the Academy's Affiliated & Associated Societies" held on 4 August at the Boston Conference. This year's three-hour forum provided the opportunity for leaders of the attending Management academies to workshop ways to reduce resource and administration costs, and how regional and niche conferences and member organisations can sustainably co-exist with large conference/member entities like AOM.

On the local front, I am pleased to report on ongoing ANZAM activities and planning for this year's ANZAM Conference, as well as some new initiatives your ANZAM Board has recently implemented to benefit members.

Beginning with some of our latest initiatives to enhance services to ANZAM members, I would like to draw your attention to three new awards designed to recognise academic excellence among ANZAM members. First, we are pleased to introduce the <u>ANZAM Promoting Excellence in Learning and Teaching (PELT) Grants</u>. This scheme funds projects up to \$5,000 which will produce an outcome usable to ANZAM members. The call for applications is now available and closes 31 October 2012. Second, we are pleased to introduce the <u>ANZAM Case Writing Competition</u>, a scheme that supports the development of case studies specific to the Australian and New Zealand region. The winner will receive a full registration for the following year's ANZAM Conference, publication in the *Journal of Management & Organization*, and an opportunity for their case to be published on the ANZAM website. Applications close 1 October 2012. Third, we are pleased to launch the <u>ANZAM Award for Research Supervision Excellence</u>, sponsored by UQ Business School. This award consists of a cheque for \$3,000 and inclusion on the ANZAM Award Recipients Listing. Applications for both awards close on 1 October 2012.

Turning now to news of ongoing ANZAM activities, the ANZAM Mid-Year Doctoral Workshop was held at Victoria University in Melbourne on 17 August. A broad range of practical guest presentations were given, ranging from time management, publishing while working on your PhD, and the ups and downs of life as an Early Career Researcher (ECR). I thank the Victoria University Department of Management for sponsorship of this event, as well as Doctoral Reps Eraj Ghafoori and Poh Yen Ng for organising this very successful Colloquium.

The <u>ANZAM Year-End Doctoral Workshop</u> will be held on 3-4 December in Perth, hosted by the School of Management at Edith Cowan University (Mount Lawley Campus). Amongst other highlights, the Workshop provides participants an opportunity to meet with the ANZAM Conference Keynote Speaker. Registration is essential and is now open.

This year's ANZAM Conference is fast approaching and Early Bird Registration closes 30 September 2012. The Conference, hosted by Curtin University, will be held in Perth from 5-7 December 2012. We are extremely pleased to be featuring this year as keynote speakers **Michael Malone**, CEO of iiNet, Australia's second largest DSL Internet Service Provider; **Professor Rajnandini** "Raj" Pillai from the College of Business at California State University; **Dr Michael Schaper**, Deputy Chair of the Australian Competition and Consumer Commission; and **Professor Robert Wood**, Director of the Centre for Ethical Leadership at Melbourne Business School. The ANZAM Heads of Schools of Management (HOSOM) Network held its most recent meeting on Friday 1 June 2012 in Sydney, hosted by UTS. The incumbent Chair, George Cairns, facilitated a program focussing on budgeting issues and how the HOSOM network can be best positioned to facilitate collaboration and representation to the ABDC on key issues. To further assist network activities and benchmarking, ANZAM is currently setting up a HOSOM portal on its website. The next HOSOM meeting will be held in Perth in December, and feature an expert speaking on HR/and IR issues, including legal and institutional responsibility.

ANZAM's official journal, *JMO*, is now taking all new submissions through its <u>new ScholarOne</u> <u>electronic submission management system</u>. ANZAM members are reminded that JMO is SSCI listed, is available online ahead of print on Atypon with a DOI, and ranked as a B journal on the ABDC list. It is a journal we all can be proud of and we hope that ANZAM members will continue to send their best work to it for publication consideration.

As you can see, your Board has been extremely busy, working hard to enhance the value ANZAM as an organisation provides to its membership throughout the year and to facilitate the standing of the

Management discipline in our region in particular, with positive effects for the international community of scholars in general.

I look forward to seeing you all in Perth in December.

#### RETIRED MEMBERSHIP

We are pleased to announce the introduction of the Retired category of ANZAM Membership. It is available on the following conditions:

- 1. Retired membership shall be available to academic teachers and researchers who have ceased fulltime or part-time employment.
- Retired staff who undertake sessional or short-term contract teaching will be eligible for Retired membership.
- 3. Retired Members who return to fulltime or part-time teaching will revert to Professional membership.
- 4. Retired Members shall have the same rights and privileges as Professional Members.
- 5. Retired membership fees shall be set at the same level as Associate membership.

Ideally the Grant will result in new resources/processes/ understandings, etc, that benefit the broader Management educators' community rather than just one subject or program within one university.
