



ANZAM PELT Grants - 2020

Promoting Excellence in Learning & Teaching

Funding for projects with budgets up to \$5,000

Grant Aims

ANZAM PELT Grants aim to provide funding support for **new** projects to develop management teaching in Australia and New Zealand. The project will ideally result in new resources/ processes/understandings that benefit the broader community of ANZAM management teachers, rather than just one subject or a single program within one university. Expected outcomes would typically include (but are not limited to) at least one new teaching resource for the use of the ANZAM community, to be uploaded to the ANZAM webpage. Applications that inform online teaching and learning are particularly sought.

PELT Grant Criteria

- Practicality and ease of adoption relative to the benefit – will it be easy to use?
- Value of outcomes –does it teach things that matter?
- Value for money – will it appeal to a broad range of teachers, relative to the cost?
- Project feasibility - is the project outcome realistic?
- Collaboration across universities (Australia and New Zealand) – can it be developed and/or used in both countries?
- Is there evidence in the proposal that the material will be developed in a concise user friendly way

Your application (**3 pages maximum** in 12pt Times New Roman only, non-appendix) should include the following information:

Project Title

Project Investigators

Lead Chief Investigator (CI) needs to be an ANZAM member in the year of application. You may have partner investigators who are not current ANZAM members. Please include the following details for each Chief Investigator:

- Name
- University
- Position/Level

Justification of the Project

A clear outline of the justification of why the project is necessary and valuable to the ANZAM community.

Aim/s of the Project

Clear outline of what you intend to achieve with this project.

Approach

A brief description of the methods and activities that will be used, what classes and types of students will be involved, which university, the roles taken by the CIs, etc.

Anticipated Outcomes

A clear outline of the intended outcomes as a result of the Grant. Demonstration of how these outcomes would benefit management education.

Priority will be given to Grants that show clear online teaching and learning outcomes in relation to management education in Australia and New Zealand.

Anticipated Budget

All budget items to be funded by the Grant need to be specified. Where final figures are not known, estimates can be provided and justified. Budget items can include, but are not limited to: research assistance, travel (directly related to conducting the project - not conference travel), required software/hardware, teaching assistance, support for development of teaching materials, learning design support, etc. ANZAM will not fund budget items that would normally be covered by the investigators' host university (e.g., standard computer equipment, teaching staff, printing, photocopying, telephone calls).

Please note it is your responsibility to ensure that your institution will allow you to have access to the funds if you are successful.

Project Timeline

The project must be completed in the year following the award, with the learning resource available to the ANZAM community one year following award announcement. Recipients are expected to present their winning project at its completion, at a time to be determined by the Academy Manager and applicable Conference Chair.

Submitting your Application

Please submit your written proposal to the ANZAM Academy Office at anzam@anzam.org no later than **5.00pm, Friday 4 September 2020**. In fairness to other applicants, we regret we cannot accept late, incomplete, or incorrect applications.

By submitting your application, the lead CI (or nominee) agrees that, as a potential recipient of the grant, they will present a Masterclass or Professional Development Workshop in association with the ANZAM Conference in the following year.

The selection panel's decision of successful awardees will be final; no correspondence about decisions will be entered into. The selection panel further reserves the right not to award a Grant if the quality of the application/s is not deemed sufficiently high.

Applicants will be notified of the outcome, then the names of the winner/s will be published on the ANZAM website and via social media in December 2020.
