

# Call for two indigenous representatives to join the ANZAM Board for 2025-2026.

- 1 Position representing Aboriginal and Torres Strait Islander Peoples from Australia
- 1 Position representing Māori from Aotearoa New Zealand



The Australian and New Zealand Academy of Management (ANZAM) was founded in 1985 to advance management education, research, and practice in Australia, New Zealand, and beyond. ANZAM is the primary professional body for management educators, researchers and practitioners in Australia and New Zealand and Institutional members predominantly from Australian and New Zealand universities. ANZAM offers Professional, Associate, and Retired Membership to individuals who are management educators, researchers or practitioners, and Institutional Membership to higher education providers of management education and research.

ANZAM's activities provide opportunities for members to share their research and teaching insights, network, collaborate and learn from stakeholders and alliance partners around the globe. We welcome to our membership everyone who is interested in advancing management knowledge and practice.

# CRITERIA:

- Candidates must be based in Australia or New Zealand to be nominated.
- Candidates and nominators must be current financial members of ANZAM in the category of: Life Fellowship, Fellow, Professional or Retired member. Associate members are not eligible to apply.
- We seek one member who identifies as a descendant of the Aboriginal and Torres Strait Islander Peoples of Australia and one member who identifies as a descendant of the Māori people of New Zealand.
- These representatives will be elected with respect to their expertise as Indigenous management scholars, academics, or practitioners to ensure that Indigenous perspectives are integrated into Board deliberations and decisions. Only ANZAM members who identify as Aboriginal, Torres Strait Islander or Māori are eligible for election to these positions.
- Adherent to section 4(2)(g) of ANZAM's Constitution, ANZAM members from Regions 1-4 can nominate and vote on the Australian Aboriginal and Torres Strait Islander representative. While members from Region 5 can nominate and vote for the New Zealand Māori representative.

Nominations are called for one Aboriginal and Torres Strait Islander Representative and one Maori Representative to sit on the ANZAM board. These are newly created positions, approved by ANZAM's members at the December 2024 AGM.

Nominations must be in writing and signed by both nominator and nominee who must both be financial ANZAM members in the Life Fellowship, Fellow, Professional, or Retired Member category. Associate members are not eligible to apply.

At the request of ANZAM, you may be required to submit a brief statement supporting your nomination (which may include: BIO, CV and a brief supporting statement).

Board company directors are required by law to hold a Director Identification number (Director ID). Successful candidates will be provided the process to obtain a Director ID and this is a mandatory requirement.

ANZAM Aboriginal and Torres Strait Islander and Māori Representative responsibilities (not exhaustive):

- Serve as conduit between ANZAM and ANZAM's Institutional Members on matters relating to Aboriginal and Torres Strait Islander or Māori issues
- Promote ANZAM to Management-related disciplines, academics
- Attend and Report quarterly to ANZAM Board meetings on:
  - ANZAM Aboriginal and Torres Strait Island or Māori activities
  - Upcoming events, promotional activities, engagement

- Advise the board on matters relating to Aboriginal and Torres Strait Islander or Māori communities/activities

- Attend all ANZAM Board meetings (mixture of virtual and face to face)
- Attend annual ANZAM Doctoral workshop and Conference and other ANZAM events (where possible)
- Serve as a member of one of the ANZAM Board Committees
- Be able to acquire a Director ID
- Other duties as required from time to time to support ANZAM Board activities and or represent ANZAM

Please note that Board representatives elected can hold office for a period of up to three years. At the end of their second year, they may choose to serve a further year, with the support of their institution and by mutual agreement with the Board.
