Welcome to the December newsletter of the Journal of Management & Organization. We are a quartile 1 Scopus indexed journal indicating that we are in the highest quality quartile. I have just come back from the Australian and New Zealand Academy of Management conference which was highly enjoyable. There were fantastic speakers and the conference included two meet the editor sessions at the doctoral colloquium and in the general conference. More than 9 editors were included (including myself) at the general conference meet the editors session and there was lively discussion about topics including artificial intelligence as well as key issues facing journals, editors, authors and reviewers in the current business management landscape. Melbourne weather was temperamental at the conference, so we had both cold and very hot days but being across from the beach proved useful for many given the nice waterfront and cool breeze.
